He requested that notices be sent in advance of the event, should include emergency number at the closure, and should also be aware of bridge closures and weight restrictions. It was noted that Amaranth bridge on the 7th Line is now closed indefinitely, and a bridge in Grand Valley now has weight restriction, and trucks would be too heavy to cross.
