- 11.2 Chief McNeilly discussed the issue they are having with their communication system, experiencing interference. He contacted Spectrum who will charge \$700.to do inspection, but would waive fee if work is done to move antenna, which is currently only 50 feet high. To move the antenna to the Grand Valley water tower, it will cost \$15,500, but will provide better paging and more clarity on truck radios. If Grand Valley Council in agreement, Fire Department will need engineer's drawing, approximate cost of \$200. There is approximately \$11,000. in reserves. Motion passed.
